General Directions to the Des Plaines State Fish and Wildlife Area

Located ten miles south of Joliet and 55 miles southwest of Chicago in Will County, the site is accessible from Interstate 55 (south of I 80), exit 241 (North River Road).

Directions to the West Grounds (Check in Station)

From the North River Road exit, continue to the top of the ramp and turn right (west) on River Road. Follow the road along past the trap and archery ranges. The check-in station is the building in the parking lot on the right (east side).

COVID-19

All precautions, as advised by the State of Illinois, will be in effect and enforceable by the host clubs. Non-compliance may result in a forfeit of entry.

Special Notice

Illinois requires all Hunting Test and Field Trial participants to carry a valid hunting license and habitat stamp. This included gunners, handlers, and scouts. The law does not apply to non-residents who wish to participate in these events. The sponsoring club will obtain a waiver of license for non-resident participants.

Eligibility and Risk

Open to all pointing breeds in good standing with the AKC. AKC-registered dogs must be six months of age or older on the event date. ILP/PAL dogs are eligible to participate. Bitches in season are <u>not</u> allowed and are <u>not</u> allowed on the grounds. Dogs are ineligible to enter a test if the test's Judge or Judge's family member has owned, sold, leased, boarded, trained, or handled the dog within one year of the test date. Owners or handlers entering a test do so at their own risk and agree to assume responsibility for any damage caused by them or their dogs.
